Instructions for filling of application form for LL.M

The students interested to seek admission for **LL.M Course (Intake - 60)** should carefully go through the following instructions:

1. The interested student must fill up an online form for LLM course during the academic year 2021-22 made available in the link provided.

2. Only duly filled up online applications received from official link will be considered for the generation of merit list for admission to the LL.M Course 2021-22 and no offline form will be considered for the same.
3. The student must fill up all details in the online application form. Incomplete forms will not be considered for generation of merit list.
4. Further it is explicitly made clear that filing of online form is mandatory for generation of merit list and it is not the confirmation of admission to the LL.M course.
5. The student must pay the non-refundable processing fee Rupees 200/- by Demand Draft drawn in favour of "**The Principal, Yashwantrao Chavan Law College, Karad**" or by online mode or they can directly pay in the College office. (The paid Receipt must be uploaded in the online Application Form)
