Address by Guest of Honor: Hon. Shri Kiran Bagi, Registrar (Judicial) - High Court of Bombay at Goa Bench has delivered his address on the topic of changes in consumer laws. At the beginning he felicitated organizers for organizing national webinar. In his address he stated that considering the needs of the people, the Consumer Protection Act, 1986 was enacted. However in the global scenario, tremendous changes in trade, commerce, social conditions and adoption of E-commerce, the Act of 1986 was not able and sufficient to cater to the needs of the people. So legislature has enacted the Consumer Protection Act 2019. As we know that, whenever an old Act is repealed and new law is enacted, it is equally important to study the radical changes between the two. The new law has widened horizon right from the definitions up to the enhancing the pecuniary jurisdiction of the District, State and National Commissions. Even the names of the Forums have changed as Commissions. The disadvantages of old Act are encountered and new provisions are enumerated regarding e-commerce, e-filing, unfair trade practices, procedure for appeal. Mediation is an important thing which is introduced by this new Act. Mediation is an alternative disputes Resolution. So, all these new features and radical changes will be meticulously discussed under the guidance of the eminent chairpersons and the resources persons of the various sessions. At the end he expresses his gratitude towards participants and organizer.

Presidential Note: Hon. Dr. Indrajeet Mohite, Vice-President, Bharati Vidyapeeth, Pune chaired the inaugural session. He felicitated organizer and participants of webinar. He then stated that the focus today being on the new Consumer Protection Act, 2019 which has come into effect from 20th July 2020, unfortunately bang in the middle of pandemic which has necessitated this webinar. The process of protecting the consumer interest is paramount, especially due to advent of technology and the introduction of e-commerce, paradigm shift of the market, advertisement assurances and services. The consumer must be made aware regarding his right in this multi-factorial scenario. Key Note Address: Dr. Pratapsinh B. Salunkhe, Former Principal, DES Law College, Pune delivered keynote address of the webinar and opened the themes for further discussion. He stated that the Consumer Protection Act was long awaited legislation right from 1950. So alongwith constitution, in fact, we were expecting another legislation that was the consumer Protection. But in the first phase, it took almost 36 years to enact the first legislation of the consumer rights and that was the Act of 1986. The first, we witnessed the amendment in 1991, then in 1993 and then in 2002. It has widened the scope and ambit of the Consumer Protection Act, 1986. So, these amendments were really important. But for this time, we were not complacent with those amendments and that is why, entire new legislation, a brand new legislation, which we have enacted because those amendments were not witnessed by us, those were not perceived by us as sufficient because time is changing very fast and we have to keep pace with the changing circumstances and that is the thing which we have to keep in our mind and that is why, 2019 Act has been enacted which aims to manage the consumer grievance in a quick and efficient manner. It should not happen that the person is unhappy, person is aggrieved by a particular defect in service or defect in goods and it is taking years together to settle that particular grievance and that is what, which is the real objective behind the enactment of this legislation. He covered all aspects of consumer law enacted in 2019 along with its pros and cons.


Activity - I

One Day Workshop on "Stress Management"




Report
