

**Thursday, 28/11/2019**

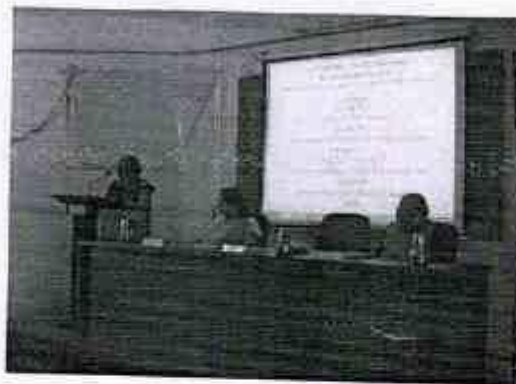

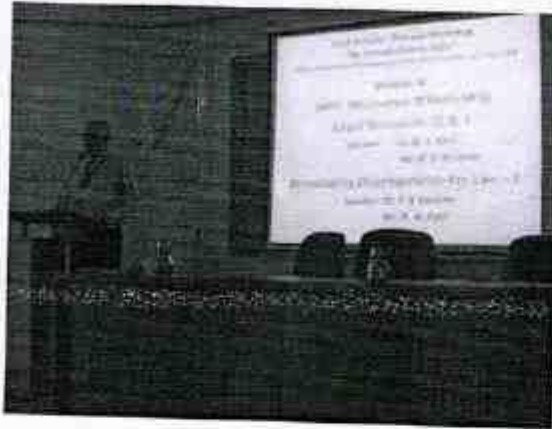
