





About the Competition

The Intra-University moot Court Competition in Vernacular language i.e. in Marathi has been organized by the Shahaji Law College, Kolhapur on 23rd Dec. 2021.

This competition has been arranged on the occasion of 23rd death anniversary of Padmashree Deshbhakt Ratnappa Kumbhar, Founder of The Council of Education.

In this competition all seven law colleges within the jurisdiction of Shivaji University have been participated.

For the moot court competition decided case law has been given, namely Sushil Kumar Dang Vs Prem Kumar Dang, AIR 1976 Delhi 321. The case is about the Section 9 and 10 of the Hindu Marriage Act, 1955.

No registration fee has been charged for participating in the competition.

Travel Plan:

On 23rd December, 2021 at 7.45 am started journey from BV's Yashwantarao Chavan Law College Karad and reached at 9 a.m. at Shahaji Law College Kolhapur. After completion of programme come back to Karad on the same day reached home at 7.00 pm.

Inaugural Ceremony:

The programme started by the worshipping the photo of Deshbhakt Dr. Ratnaappanna Kumbhar. Guest Hon'ble Justice (Retd) Shri. Tanaji Nalavade felicitated by the respected principal of the concern college. After that Dr. M.C. Sheikh sir showed unforgettable memories of Deshbhakt Padamashree Dr. Ratnaappanna Kumbhar (B.A. L.L.B, D.Litt) Founder President of The Council of Education, Kolhapur through the power point presentation.



Principal of the college Dr. Rayadurgam Narayana gave an introductory speech of the programme.

In the inaugural address the Hon'ble justice Nalawade encouraged new students to work in litigation practice. He also emphasized upon and importance of honesty regarding work. He shared his view on the valuable work done by Deshbhakt Padamashree Dr. Ratnaappanna Kumbhar. He appealed that students must have to work for society by keeping moral values in mind.

Then vote of thanks given by Dr. M. C. Sheikh sir of the concern Law College and moot proceeding started.

The competition:

There were seven teams for the moot court competition. In the competition every team had to present the case within 20 minutes. Each party has to present the facts, issues, arguments and prayer within 10 minutes including questions put forth by the presiding judge. Shri. Tanaji Nalawade, Hon'ble Justice himself presided over as

moot judge.

We have been allotted Team Code A4 for Appellant and R4 for Respondent and RE4 for the Researcher.





On receiving a call we have presented our case before the court, made arguments and responded to questions asked by Hon'ble judge.

We come to know that the Research is the very important skill while writing memorial, case law study, reading articles, collecting information of related case laws.
