REPORT

A one-day programme on the occasion of International Human Rights Day (10 Dec.) has been arranged in multipurpose Hall of the college on Saturday, 10th Dec. 2022 at 11.00am.

For this program Adv. Shreyas Kolekar, a practicing advocate has been invited as Chief guest and the program was presided over by Prof. Uday Sawant sir as a Chair-person in the august presence of Prof. Satish Mane, i/c Principal of the college.

Programme has been arranged in three sessions viz. Inaugural session with Welcome of newly admitted students, Human Rights Awareness session and session third on introduction of Certificate courses.

Prof. Satish mane sir has delivered introductory speech. He has stated the history of college and of Bharati Vidyapeeth. He welcome all the newly admitted students in this college. He has also shared his thoughts on human rights.

Adv. S. S. Kolekar has enlightened the students about the law faculty and career opportunities in this sector. He appealed the students to prepare themselves for the future. He has stated that, How a lawyer can change the scenario of society? How a lawyer can be mediator in implementing human rights at grassroot level, How a lawyer can be activist?. He has shared some important tips for the students to be a good lawyer.

Prof. Uday Sawant sir has given his presidential speech. In his address he encouraged the student, he appealed the student to be pro-active in teaching and learning process. He welcomed the students in this avocation. He declared that the program is inaugurated.

In session second Dr. Archana Thorat has delivered her address on 'Universal Declaration of Human Rights'. She has elaborated the historical development of UNO and UDHR. She has explained the various organs of UNO, significance of ECOSOC and Human Rights Commission. She has discussed the Charter and provisions of UDHR.

Dr. M. S. Khairnar has discussed "Indian Constitution and Human Rights'. The relation between UDHR, Constitution, and human rights is integral and inter-dependent. He discussed the historical development of the present constitution right from Govt. of India Act 1935. He explained the parts of the constitution,



significance of articles 14, 21, 32 and others. He discussed Fundamental Rights, Fundamental Duties, and Directive principles of State policy.

In third session information about the certificate courses of department of Lifelong Education and Extension of Shivaji University, Kolhapur has been shared.

Prof. Ram Mohite shared the information relating to Certificate course on Panchayat Raj. The course given to NLC I students. The object of the course is to broaden the view of students about the local self-government.

Dr. Mahendra S. Khairnar has given information about the 'Certificate Course in Human Rights'. He discussed the importance of the program. This course necessary to sensitize the law students about the human rights situation in locality.

In concluding session interaction took place with students. Students have shared their views and opinions. Students have given positive feedback towards the admission procedure implemented in the college.

Report of Webinar






Introduction of the programme and Welcome of the guests and attendees done by I/c Principal Mr. Satish Mane.



Girl Child Safety [Bharosa Cell]


A Report:

The discipline committee {2020-21} of the college has taken initiative to conduct a program in collaboration with Karad City Police Station. The program was organized on Friday, 13th August, 2021 for girl's students only. The program was proposed by Maharashtra State Government and Maharashtra State Mumbai Police for the safety of girl child with the name as "Bharosa Cell", in this cell the safety of a girl child is made the priority so that any crime or any bad act or any such mental disturbances can be curtailed in the initial stage itself, and for the same the officers work 24 hours. The police officers under this cell are called as 'Police Didi' and 'Police Kaka' so that the complainant feels comfortable and friendly while narrating any mishap.

This Cell is 24 hours actively working and patrolling cars are also provided for the same cause. As per the point raised in the Discipline committee meeting the college has taken this opportunity to organize a lecture of Ms. Haseena Harun Mujawar, Head Constable, Karad City Police Station.
