





She has been invited to interact and guide the students on this occasion.

Adv. Dipali Khurd has given nice information about Rajmata Jijau and Swami Vivekanand. She has explained the historical moments and linked the same with contemporary challenges. She expressed her view that how Shakti and Bhakti i.e. Power and Dedication are having close relation with each other. These two are necessary not only to construct the society but to develop and nourish the society. She explained in simple marathi language that how Mother Jijau has nourished the Shivaji and how she inculcated values and virtues in the mind of young soldiers i.emavala. Only strength is not suffice but intellect has its own role in the maintenance of Swarajya. She elaborated that how Jijau has develop the Poona and what sufferings she has received in transforming the society. Jijau's father Lakhojirao Jadhav has taught her uses of weapons and selfdefence, horse riding, made her literate to write and express her thoughts. 
