Medical practitioners are more involved in female feticide cases.

Dr. Yugantara Kadam interacted with the gathering on health related issues of every woman. She said that a woman should understand to take care of herself first. If she is fit then she can do anything for other members of family.

Mrs. Malantai Mohite discussed about the political independence of women. She is from political field and experienced that men are leading the women. She said that though the reservation is given to women in contesting the election. Still today her husband and relatives takes command over her and compels her in taking decisions not of her choice.
