### **Objectives of the Course:**

The criminal trial involves increasing expenditure of government resources. At the same time, it confronts a crisis of intrusion into individual rights in order to protect the common weal. The Bharatiya Nagarik Suraksha Sanhita 2023 has replaced The Code of Criminal Procedure, 1973. Obviously, Suraksha Sanhita has to be just, fair and reasonable to the accused as well as to the victims. Undoubtedly the process is to be carried out in an objective manner. The Bharatiya Nagarik Sanhita 2023, thus, makes a balance of conflicting interests. This imposes a duty upon those connected with the working of the criminal process to abide by the law and to exercise discretion conferred on them in the best manner. Suraksha Sanhita is to be discussed with its practical approach in classroom discussion. However, the students should obtain a fair idea of how the Suraksha Sanhita works as the main spring of the criminal justice delivery system and should be exposed to the significant riddles of the procedure.

#### **Teaching Learning Methods:**

Lectures including class room discussion, inviting experts like judges, senior Advocates for interacting sessions, guest lectures etc are good teaching learning methods.
