LAW OF CRIMES I- (Bhartiya Nyaya Sanhita)

In a developing society crime has become dispensable part, it is impossible to strike it done in toto, but it can be controlled and punished through criminal legislations. In India, The Bhartiya Nyaya Sanshita (BNS) 2023 is the substantive law which primarily concerns the crime and its punishments. The Bhartiya Nyaya Sanhita (BNS) 2023 aims to modernize and streamline India's criminal justice system by replacing the Indian Penal Code (IPC) of 1860. The BNS reflects contemporary legal principles and societal values, and addresses various aspects of criminal law, including definitions of crimes, punishments, and procedural regulations. So proper understanding of the offences & criminal behaviors, methods of controlling them has now become extremely important in the larger context of Indians development & to build a just and humane society.

Object: This course is designed with the following objectives

- To give an overview of all the offences and punishments with the help of various provisions of new Criminal Law.
- To familiarize students with the principles of substantive criminal law
- To understand the meaning of crimes, methods of controlling them and the essential principles of criminal liability
- To provide knowledge of offences and punishments under The Bhartiya Nyaya Sanshita 2023.

Learning Outcomes: After the successful completion of course, students are able to:

1. Understand and remember the basic concept of crime, punishments, criminal liability and criminal behavior.
2. Analyses and interpret various offences and punishments under substantive criminal law.
3. Evaluate and investigate the crimes from the point of view of the requirements of substantive criminal law.
4. Elaborate the criminal laws to formulate and build a just and humane society.
