## Seminar Presentation and viva voce

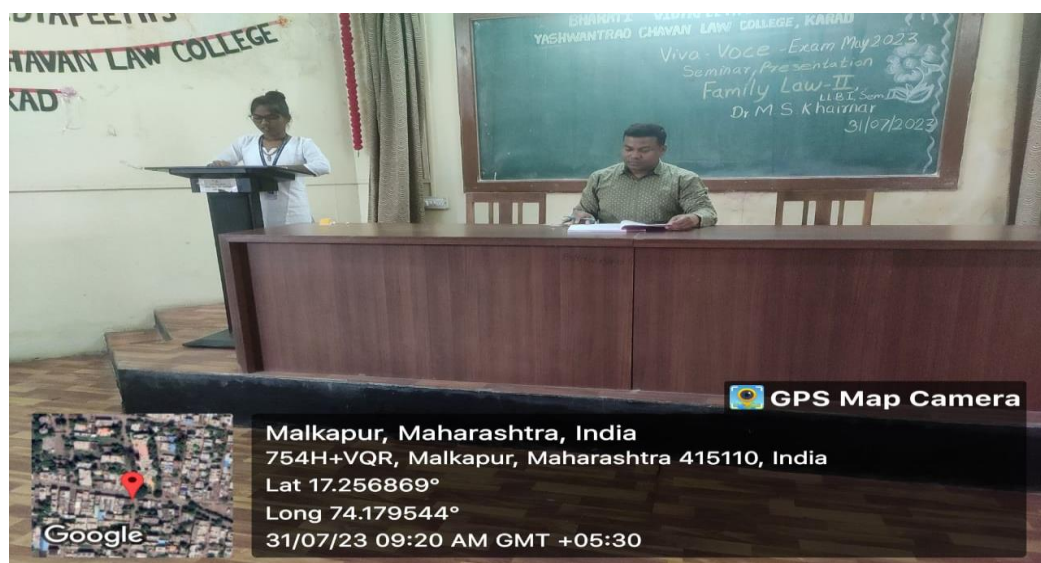

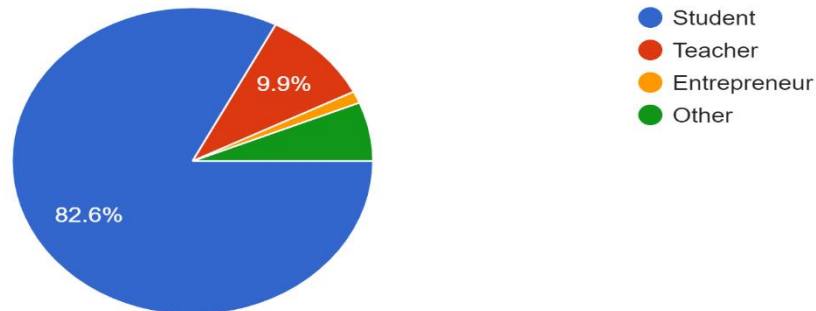
